### **2017 RIDER SAFETY PACK PROMOTION**

# Customer Terms & Conditions (the "Terms")

### Eligibility

- 1. This promotion is open to UK, Channel Island and Isle of Man residents aged 18 years or over at the date of entry. Employees of the Promoter and its associated companies, dealers, agents and members of their immediate families or anyone connected to the creation and administration of the promotion shall not be eligible to participate in the promotion.

# How to Participate

- 5. In order to participate in this promotion, the participant must register the Qualifying Vehicle by the closing date by completing the Handover Form ( **"Form"**), which will be provided to the participant at the point of sale, and returning it to the dealer. The participant must also advise the dealer of the participant's size requirements when the Form is returned.
- 6. Only one Form may be submitted per Qualifying Vehicle purchased.
- 7. The dealer may ask for proof of purchase of the Qualifying Vehicle on submission of the form.

- 12. The colours and sizes of the helmet and gloves within the Rider Safety Pack may vary. In the event an item or items of the Rider Safety Pack are not available, the Promoter will use reasonable endeavours to supply an item or items of similar specification of the same or greater value.
- 13. No cash alternative is available.

- 15. Rider Safety Packs are available for people over 12 years old. In accordance with the Owner's Manual/Operator's Handbook provided with the Qualifying Vehicle. The Promoter does not recommend that riders under the age of 12 years old operate the Qualifying Vehicles.
