

## **HONDA OUTBOARD MOTOR PROMOTION 2017 (THE "PROMOTION")**

### **CUSTOMER TERMS & CONDITIONS**

#### **1. PARTICIPANTS**

- 1.1 This Promotion is only open to UK residents aged 18 years or over.
- 1.2 By participating in this Promotion, all participants are deemed to have agreed to be bound by these terms and conditions.
- 1.3 This Promotion is only available on in-store and / or online purchases of selected new Honda outboard motors (and as more particularly set out in clause 2.2 below) ("**Eligible Outboards**") from participating UK Honda Marine Authorised Dealers.
- 1.4 This Promotion allows qualifying customers to receive a "saving" on the purchase of Eligible Outboards made in the following ways:
- a) In-store purchases made from a participating dealer ("**In-store Purchase**"); and
  - b) Online purchases made from the website of a participating dealer ("**Online Purchase**").
- 1.5 Employees of the Promoter, its associated companies, their families, agents and other parties directly involved with this Promotion are not eligible to participate.

#### **2. SAVINGS**

- 2.1 This Promotion is for "savings" on Eligible Outboards. The specific saving amount will be applied at the point of purchase and deducted from the purchase price. No alternative arrangement will be entered into.

Only one saving will be applied to each Eligible Outboard but participants may purchase up to a maximum of 5 (five) Eligible Outboards with this Promotion.
- 2.5 Delivery options for purchases made from a participating dealer may vary. Please contact your dealer for information.

### **3. HOW TO PARTICIPATE**

- 3.1 Purchases must be made by the customer and registered (by the dealer) between Thursday 13 April 2017 and Saturday 30 September 2017 ("**Closing Date**") (both days inclusive) to take advantage of this Promotion. Purchases made after Saturday 30 September 2017 will not be eligible for the Promotion. Trading hours for In-store Purchases vary by Dealer.
- 3.2 Internet access is required for Online Purchases and the procedure for purchases made through a participating dealer's own website may vary by dealer.
- 3.3 The Promoter accepts no responsibility for purchases not made by the Closing Date and any purchases made after the Closing Date will not be eligible for the Promotion.
- 3.4 It is the participant's responsibility to ensure that sufficient and correct details are provided at the point of sale for the saving to be applied.
