

## **HONDA HONWAVE PACKAGE PROMOTION 2019 (THE “PROMOTION”)**

### **CUSTOMER TERMS & CONDITIONS**

#### **1. PARTICIPANTS**

- 1.1 This Promotion is only open to UK residents aged 18 years or over and excludes the Channel Islands and Isle of Man.
- 1.2 By participating in this Promotion, all participants are deemed to have agreed to be bound by these terms and conditions.
- 1.3 This Promotion is only available on purchases of selected Honda Honwave packages (and as more particularly set out in clause 2.2 below) (“**Eligible Packages**”) from participating UK Honda Marine Authorised Dealers.
- 1.4 Employees of the Promoter, its associated companies, their families, agents and other parties directly involved with this Promotion are not eligible to participate.

#### **2. SAVINGS**

- 2.1 This Promotion is for ‘savings’ on the **Eligible Packages**. The specific saving amount will be applied at the point of purchase and deducted from the purchase price. No alternative arrangement will be entered into.

to each Eligible Package but participants may purchase up to a maximum of 5 (five) qualifying packages with this Promotion.

### **3. HOW TO PARTICIPATE**

- 3.1 Purchases must be made and registered during trading hours between Monday 15 April 2019 and Monday 30 September 2019 (both days inclusive) to take advantage of this Promotion. Trading hours vary by Dealer.
- 3.2 The Promoter accepts no responsibility for purchases not made by the closing date and any purchases made after Monday 30 September 2019 will not be eligible for the Promotion.
- 3.3 It is the participant's responsibility to ensure that sufficient and correct details are provided at the point of sale for the saving to be applied.
- 3.4 Any participant who seeks to participate in this Promotion in breach of these terms and conditions will be disqualified. Any fraudulent, illegible or incorrectly completed information will also be disqualified and not qualify for the Promotion.
